## Terms and Conditions for the use of the swimming pool Outdoor swimming pool at "Polanki 23"

## 1. General part

1) The swimming pool is an unattended facility and therefore minors must be supervised by adults

who are are fully responsible for them at all times while on the premises.

2) Before using the pool, you must familiarise yourself with these terms and conditions which must be observed during the entire stay.

3) Beginning to use the pool is tantamount to knowing and accepting the terms and conditions.

4) The facility is open Monday through Sunday from10 a.m. to 7 p.m. from 1 June to 10 September.

5)The following is strictly prohibited in the swimming pool area:

- bringing, consuming and selling alcoholic beverages
- drinking, drugs and other intoxicants, psychotropic drugs
- bringing glass containers and other sharp instruments and dangerous objects
- the presence of animals

• entry of persons whose condition indicates consumption of alcohol or any kind of intoxicating

drugs

## 2. The terms and conditions for the use of the swimming pool

1) People shall only enter the swimming pool once footwear has been removed.

- 2) A maximum of 10 people can use the pool at any one time.
- 3) In the swimming pool area the following is prohibited:
- running around the pool area, walkways and around the pool area
- pushing other users into the water
- jumping into the water
- climbing the pool walls
- throwing dishes, food scraps, or objects into the water
- bringing sharp tools, glass containers and cutlery into the pool area is prohibited
- Eating, drinking, smoking and chewing gum in the pool are prohibited
- Damaging equipment
- contaminating pool water or pouring water out
- tampering with the jets
- sitting on the edge of the pool

•swimming naked; users, including children over two years of age, must wear a bathing suit or swimming trunks and younger children wear a nappy

• pool users must not endanger the safety of others

pool-goers.

4) It is forbidden to use the swimming pool for persons who show symptoms indicating : skin diseases, ringworm, open cuts, warts, skin diseases, rose etc., infectious diseases, difficult-to-heal

wounds, lack of personal hygiene, epilepsy, breathing difficulties, balance disorders, aggressive behaviour, cardiovascular disease, people with unstable and worrying health conditions.

5) The pool manager shall not be liable for the health consequences of the presence of these persons in the pool.

## 3. Liability and penalties

If the equipment is damaged or lost, 100% of the value of the goods will be charged.

2) The swimming pool manager is not responsible for lost items on the premises of the facility

and the swimming pool.

3) The swimming pool operator shall not be liable for accidents caused by failure to observe the

terms and conditions.

The facility is under constant surveillance and camera footage may be grounds for holding users liable if they do not comply with the terms and conditions. The Manager ensures that monitoring is carried out in a manner that does not violate personal rights and dignity

of users.
